

## School Po

After three consecutive or a total of five unlawful absences, regulations require that school officials contact the parent/guardian for a conference. The purpose of this conference is to identify reasons for your student's absences and to complete a Student Attendance Intervention Plan.

The maximum number of days a student allowed to miss is TEN per school year (lawful or unlawful.) When a student is absent more than 10 days, attendance is a key factor used in the promotion/retention decisions for grades K5.

Section 163-510 - Organizations and entities revised (hazing unlawful; definitions). Section 59 19-90 - General powers and duties of school trustees. Section 5963-110, et seq. Safe School Climate Act.

Sections 5963-210 through 270 - Grounds for which trustees may expel, suspend or transfer pupils; petition for readmission; notices and parent conferences; expulsion for remainder of year and hearings; transfer of pupils; corporal punishment; regulation or prohibition of **d**bs or like activities.

Section 5963-275 - Student hazing prohibited. Section 5967-240 - Other duties of bus driver; discipline of students for misconduct.
